
Properties can be let if they have an energy rating from A to E.

Primary energy use

The primary energy use for this property per year is 330 kilowatt hours per square metre (kWh/m2).

How this affects your energy bills

An average household would need to spend £2,622 per year on heating, hot water and lighting in this property. These costs usually make up the majority of your energy bills.

You could **save £1,531 per year** if you complete the suggested steps for improving this property's energy rating.

10. Solar photovoltaic panels	£3,500 - £5,500	£452
